# 225.16 To receive an update on land at Little Moor, Hauber Lane and consider further action.

# 226.16 To receive an update on the funding for a village defibrillator.

The cost of an NHS defibrillator is £435 + VAT and the exterior unit is around £380. The cost of training is not yet know. It is agreed the defibrillator will be placed on the outside wall of the Village Hall in partnership with the Primary School.

# 227.16 To receive an update on the state of the Church Graveyard – Cllr Joyce

Cllr Joyce had received an email response from Canon Turner with regard to the overgrown grass in the Graveyard. The sheep were removed without the knowledge of the Church following complaints. In Spring Canon Turner will try to arrange for the sheep to be brought back to cut the grass.

## 229.16 Correspondence and matters brought to the attention of the Chair.

Lighting – Councillor Briggs had met with Peter Ball of NYCC to map the lights in the village and to consider which could be handed over to NYCC.

Brearlands should have an LED near the top and can then be handed over. This would cost £1200.

Main Road – Two lights required at gateway. A larger, taller (6 mtrs instead of 5mts) LED lamp needs to be placed at the junction with Church Road. Highways would take on from the junction to the 30mph signs. 4 + a top required on Main Road for NYCC to take over.

Booth Bridge Lane – 1 modern LED required by cottages.

Peter will email a Plan and cost for us to discuss at the next meeting.

The Parish Council objected to a modern, brighter lamp at the junction as this was not in keeping with the lantern style lamps through the village.
